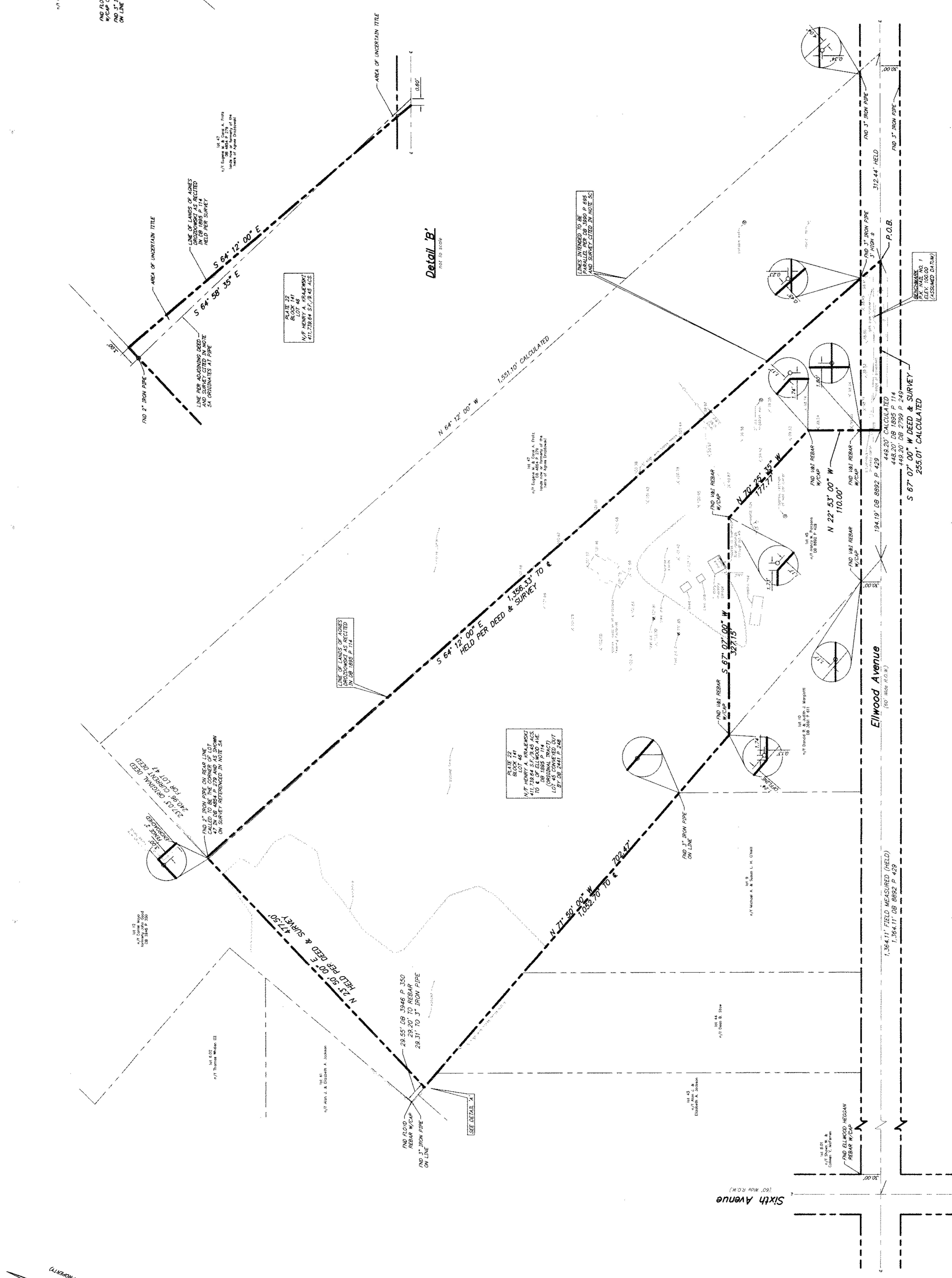


**Detail 'A'**
